AN ACT TO AUTHORISE SUPPLEMENTARY APPROPRIATION OF MONIES  
OUT OF THE CONSOLIDATED FUND FOR RECURRENT EXPENDITURE FOR  
THE SERVICE OF THE YEAR ENDING 31 DECEMBER 2017 (NUMBER 2)

**Short title:**

1. This Act may be cited as the Supplementary Appropriation (No.2) Act 2017.

**Authorisation of issue of \$45,661,837 from the Consolidated Fund**

2. The issue from the Consolidated Fund is hereby authorized of a sum of \$45,661,837 to be applied for recurrent expenditure to the service of the year ending 31 December 2017.

**Appropriation**

3. The sum specified in section 2 shall be appropriated for the supply of the Heads of Expenditure specified in Column 1 of the Schedule annexed to this Act in the sums respectively specified in relation thereto in Column 2 of the Schedule.


